- 3) the obligations to maintain or operate infrastructure or assets could continue for 10 years or more;
- 4) the contract involves a privately financed project as defined by guidelines published by the Treasury; OR
- 5) the contract involves a transfer of a significant asset of Council concerned to another party to the contract in exchange for the transfer of an asset to the Council.

- 2) the proposed contract (whether or not made publicly available) has been the subject of a tendering process and the terms and conditions of the contract have been substantially negotiated with the successful tenderer;
- 3) the obligations to maintain or operate infrastructure or assets could continue for 10 years or more;
- 4) the contract involves a privately financed project as defined by guidelines published by the Treasury; OR
- 5) the contract involves a transfer of a significant asset of Council concerned to another party to the contract in exchange for the transfer of an asset to the Council.
