Council is seeking Expressions of Interest (EOI) for a suitable Licensee to operate The Moama Market.

The Moama Market is held at the Moama Soundshell area in Moama NSW and this opportunity is for a market operator to conduct the operations of the market around 26 times per year, for an initial two-year period, with an option to continue.
